ELIGIBILITY CRITERIA

To be considered for the Global Gateway Scholarship, applicants must meet the following requirements:

- Academic Excellence:** Applicants must meet Churchill's course entry requirements and demonstrate strong academic performance with results equivalent to an ATAR of 70 (or higher) in their most recently completed qualification (Year 12 or equivalent), as assessed by Churchill in accordance with the [Admissions Guidelines / International Qualifications Equivalency Table](#).
- English Proficiency:** An IELTS overall score of 6.0, with no individual band score below 5.5 (or equivalent recognised English test).
- Application Status:** Must be a new commencing international student applying from offshore (outside Australia) to study at Churchill Institute of Higher Education.
- Application Deadline:** This scholarship applies to 2026 intakes only. Students must apply, accept their offer, and have their Confirmation of Enrolment (CoE) finalised before 31 October 2026. The final intake for 2026 is the December 2026 intake.
