

CHURCHILL'S DIPLOMA-TO-DEGREE BURSARY (ONSHORE)



Finished your Australian diploma and ready for the next step?

The Churchill Diploma-to-Degree Bursary (Onshore) supports onshore international students progressing into Churchill's Bachelor of Business (all majors) with a 20% tuition fee reduction.

FAST-TRACK OPTION

Diploma grads may be able to finish the Bachelor of Business in as little as 2 years (Indicative only). Based on approval of up to 8 subjects (1 year) of advanced standing and full-time enrolment, subject to subject availability/timetabling and satisfactory academic progress.

ELIGIBILITY CRITERIA

To be considered, applicants must:

- Be an onshore international student at the time of application and offer acceptance.
- Have successfully completed an Australian AQF Diploma (or higher) issued by an Australian Registered Training Organisation (RTO) (evidence required: testamur and transcript).
- Apply for and receive an offer for Churchill's Bachelor of Business (CRICOS Course Code: 111749J).
- Be a new commencing student at Churchill (not currently enrolled at Churchill).
- Accept the offer and complete enrolment requirements by the relevant intake deadlines.
- Maintain satisfactory academic progress and ongoing eligibility requirements to retain the bursary (and any approved credit).

HOW IT WORKS

- **Bursary benefit:** 20% reduction on tuition fees (tuition only).
- **Credit / advanced standing (separate assessment):** Credit is available only where the completed diploma is assessed by Churchill as relevant to the chosen Bachelor of Business major (Accounting, Hospitality, Information Systems, or Management). Eligible applicants may be approved for up to 8 subjects (1 year) of credit.

This bursary provides a 20% reduction to tuition fees only and does not apply to non-tuition charges (including but not limited to OSHC, accommodation, living expenses, textbooks, materials, visa costs, or any third-party fees). The bursary is not transferable, cannot be redeemed for cash, and cannot be exchanged for any other benefit.

Advanced standing / credit (relevant diplomas only): Credit is not automatic. Diploma graduates may be eligible for advanced standing of up to 1 year (8 subjects) only where the completed diploma is assessed by Churchill as relevant to the chosen major (Accounting, Hospitality, Information Systems, or Management). Credit is subject to Churchill assessment of prior studies (including relevance, recency, learning outcomes, and evidence provided). Churchill may approve fewer than 8 subjects or decline credit where requirements are not met. Approved credit may reduce the total subjects and tuition payable for the course.

Any reference to completing the course in "as little as 2 years" is indicative only and depends on the amount of credit approved (up to 8 subjects), the student maintaining a full-time study load, subject availability/timetabling, and satisfactory academic progress. Where less than 8 subjects of credit are approved, the course duration will be longer.

Churchill may request additional evidence to verify eligibility (including proof of Australian RTO completion and diploma relevance). If a student defers, changes course, reduces study load, withdraws, or does not meet progression requirements, Churchill may reassess eligibility and the bursary and/or approved credit may be removed.

This bursary does not guarantee admission, visa approval, employment, or migration outcomes. Students remain responsible for meeting all admission requirements and, where applicable, all student visa conditions.
